

# THE "FOX SPORTS ARIZONA FANEXPRESS PRESENTED BY COX COMMUNICATIONS" SWEEPSTAKES

## OFFICIAL RULES

### NO PURCHASE NECESSARY TO ENTER OR WIN.

**PURCHASE DOES NOT INCREASE CHANCES OF WINNING. THE "FOX SPORTS ARIZONA FANEXPRESS PRESENTED BY COX COMMUNICATIONS" SWEEPSTAKES (THE "SWEEPSTAKES") AND ANY ADVERTISEMENT RELATING THERETO IS INTENDED FOR PARTICIPATION ONLY IN ARIZONA (THE "TERRITORY") AND SHALL BE CONSTRUED ACCORDING TO, AND GOVERNED EXCLUSIVELY BY CALIFORNIA STATE LAW. 1. **SWEEPSTAKES DESCRIPTION:** The "Fox Sports Arizona FanExpress Presented By Cox Communications" Sweepstakes (the "**Sweepstakes**") is sponsored by Fox Sports Net Arizona, LLC, ("**Sponsor**") located at 455 North 3rd Street Suite 290, Phoenix, AZ 85004. The Sweepstakes begins on September 21, 2017, and ends on October 5, 2017 ("**Sweepstakes Period**"). The Sweepstakes is a promotion related to Sponsor's coverage and telecast of professional hockey games and any ancillary programming related thereto. At the end of the Sweepstakes Period, a random drawing will be conducted to select twenty-five (25) prizewinners from all eligible entries received throughout the Sweepstakes Period.

2. **WHO MAY ENTER:** The Sweepstakes is open only to legal residents of Arizona who are eighteen (18) years of age or older the time of entry. Void where prohibited by law. Directors, officers and employees, (and their respective IRS dependents, immediate family members [children, spouse, parents, sibling] and individuals residing in their same household, whether or not related) of Sponsor, CoxCom, LLC, Fox Cable Network Services, LLC, Fox Entertainment Group, and The News Corporation, Inc. (the "**Promotion Entities**") and each of their respective parents, affiliated, or subsidiary companies, advertising, promotion, production services, fulfillment agencies, legal advisors, web masters and web suppliers, if any, are not eligible to enter or win. Legibly complete the Sweepstakes entry form in its entirety and deposit the completed Sweepstakes entry form into the designated official Sweepstakes registration receptacle. Limit of one (1) entry per person throughout the entire Sweepstakes Period. All entries must be received by the end of the Sweepstakes period in order to participate. All requested information must be included on the entry form to be eligible to win. No mechanically reproduced, illegible or incomplete entries will be accepted. Sweepstakes entries will be deemed null and void and will be rejected if not submitted through authorized, legitimate channels. Sponsor in its sole discretion shall be the official timekeeper for this Sweepstakes.

All entries become the exclusive property of Sponsor and will not be acknowledged or returned. As permitted by law, each entrant agrees that personal information collected in connection with this Sweepstakes may be shared with the Promotion Entities and Sponsor's other promotional partners to contact you regarding promotional updates; information; messages; and for other reasons via electronic and/or ordinary mail and, will be used by Sponsor and such promotional partners in compliance with their respective privacy practices. Without otherwise limiting the foregoing, any personal information supplied by a Sweepstakes entrant to Sponsor will be subject to Sponsor's privacy policy posted at <http://www.foxsports.com/privacy-policy> ("**Privacy Policy**"). By entering the Sweepstakes, each entrant grants Sponsor permission to share your email address and any other personally identifiable information with the other Promotion Entities for the purpose of Sweepstakes administration and prize fulfillment. Sponsor will not sell, rent, transfer or otherwise disclose your personal data to any third party other than as described herein or in the Privacy Policy. Entry must be made by the entrant, only in the manners as set forth herein. All other methods of entry are considered void.

4. **DRAWINGS AND WINNER NOTIFICATION:** Up to a total of Twenty-five (25) prizewinners will be selected for a prize package. The potential prizewinners of the Sweepstakes will be selected in a random drawing from all eligible entries received during the Sweepstakes Period on or about October 6, 2017. Each potential prizewinner will be notified by

telephone and/or email on or about October 6, 2017, using the contact information provided at the time of entry. If a selected prizewinner cannot be reached by telephone and/or e-mail, or does not respond within two (2) days of the initial attempt to notify such potential prizewinner, the prize package may be forfeited and an alternate prizewinner may be selected in a random drawing from the remaining eligible entries. Sponsor shall have no liability for any prizewinner notification that is lost, intercepted, or not received by a potential prizewinner for any reason. 5. **PRIZE/APPROXIMATE RETAIL VALUE /ODDS:** Up to a total of twenty-five (25) prize packages are available. Each prizewinner will receive (i) one-trip ground transportation for two (2) on October 14, 2017; which will originate from COX Retail Store located at 6070 West Bell Road, Suite A111, Glendale, Arizona 85308 to the hockey arena located in Glendale, Arizona; and (ii) admission for two (2) to the October 14, 2017 professional hockey game. The total approximate retail value (“ARV”) for each prize package is One Hundred Dollars (\$100). The ARV should all prizes be awarded in connection with this Sweepstakes is Two Thousand Five Hundred Dollars (\$2,500). If a potential prizewinner is unable to attend the October 14, 2017 professional hockey game, then such potential prizewinner will forfeit the prize package in its entirety. Sponsor is not responsible for game schedule changes, delays or cancellations. The ground transportation begins and ends at the location noted hereinabove. No other stops will be allowed. A prizewinner's companion must be eighteen (18) years of age or older, or if such companion is a under the age of eighteen (18), the prizewinner must be such companion's parent or legal guardian or the companion must travel with the permission of such companion's parent or legal guardian, with such permission in a form and substance acceptable to Sponsor in its sole discretion. The prizewinner's companion must sign and return a Liability Release and (where legal) a Publicity Release prior to ticketing of the prize.
