Sponsor cannot accurately predict the number of entrants who will participate in the Contest.

9. SPONSOR'S RIGHT TO DISQUALIFY: At any time during the Contest, Sponsor reserves the right, in its sole and absolute discretion, to disqualify and remove any photograph that it believes contains any inappropriate content, infringes the rights of any third party, or otherwise does not meet the Submission requirements or any other requirements in these Official Rules. The decisions of the Sponsor on this and all matters relating to the Contest are final and binding.

10. WINNER SELECTION/PRIZE. Up to a total of forty-six (46) Winning Contestant(s) will be selected throughout the entire Promotion Period. Following the completion of the Judging Phase for each applicable Contest, potential Winning Contestant(s) (as defined below) will be selected from all eligible entries received throughout the Submission Period for the applicable Contest.
