3. HOW TO ENTER: A computer with internet access is required to participate in this Promotion. To be eligible to enter a Sweepstakes, during the Registration Period, for the applicable Sweepstakes, each entrant must log onto <https://www.foxsports.com/wisconsin/watch> ("Website") and follow the links and instructions to the Promotion's registration page. Each entrant must then complete and submit the Keyword for the applicable Sweepstakes and all other required information, which may include

without limitation entrant's full name, email address, and complete mailing address (including city, state, and zip code). Upon completion of the aforementioned process, the entrant will receive one (1) entry into the Sweepstakes.
